Subject: Revision in Modulated Price with WPI Indexation applicable from 00:00 Hours of 01.04.2025

Dear Sir,

CFDs CIL, in its 299th meeting dated 25.01.2023 approved the modalities for Indexation of supply price for NRS linkage auction on the basis of WPI index with effect from 01.04.2023. CIL has further communicated vide letter no. CIL/M&S/E 1034450/E Auction/48 dt. 30.03.2023 that Modulated Price, applicable for NRS Linkage Auction, may be used as Base Price for arriving at the Floor Price (with or without Add-on, as may be decided by the coal company) for Single Window Mode agnostic e-auction to be held on and from 01.04.2023.

As per decision of CFDs, CIL taken in its 299th meeting, the Modulated Price is to be calculated on the basis of movement of final WPI index of December every year vis-à-vis December last year and will be made effective from 1st of April of the following year, starting from 1st April 2023.

In line with the direction, revised modulated price to be made effective from 0:00 hours of 01.04.2025 and guidelines for determination by subsidiary coal companies under different cases is enclosed as Annexure - A.

The coal companies are requested to implement the above decision of the CIL CFD with intimation to the concerned consumers.
