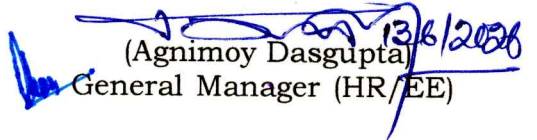
All other terms and conditions of the above-mentioned Office Order No. 1067 dated 13th May 2026 will remain unchanged.
