On being formally released from their present place of posting, they will report to the CMD of their respective subsidiaries, for further assignments.

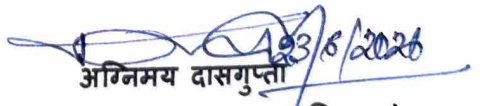
On promotion, the above Executives will be on probation for a period of one year at the first instance or date of superannuation, whichever is earlier.

The promotion will be effective on and from the date, the executives assume charge of the higher post, at their place of posting on promotion as mentioned against their names.

As per extant policy, the above executives have to join the promoted post within 60 days from the date of issuance of the Order of CIL. Non-joining on the promoted post within the stipulated time would lead to cancellation of the Promotion Order and debarring of the Executives for one subsequent DPC for promotion to the post.

The above executives are also advised to fill up their new 'PRIDE' form for the year 2026-27 within 15 days of their joining/assuming charge at their new place of posting on promotion, after taking new assignment in consultation with their Reporting Authority, failing which it will be the sole responsibility of the executives concerned.
