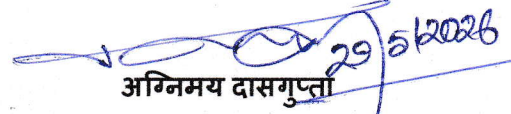

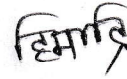
The transfer of above executive shall be treated as “Request Transfer on Mutual Basis” and will be regulated accordingly.
