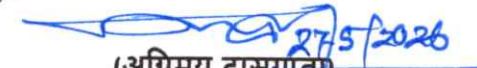
The executive concerned will be responsible for coverage of employees under Corporate Salary Package and maintaining coordination with banks/Areas.
