NOTICE

Subject: Major reforms in NRS Linkage auction tranche VIII & onwards

CIL is planning to commence tranche VIII NRS Linkage auction shortly. In relation to ensuing NRS linkage auction, certain reforms/modifications in the operative modalities have been envisaged which are mentioned below:

A. Registration process:

- a. Units/Plants/EUPs of specific subsector of a single owner/company in same or geographically different location under same PAN are allowed to register in single bidder ID.
- b. Participation in the linkage auction by the bidder will be allowed for the cumulative eligible normative requirement of the linked EUPs/units(subject to deduction of existing linkages and coal block production). However, the supply to individual EUP from all coal linkage sources will not exceed its normative quantity/requirement
- c. In case any EUP is debarred, the same EUP is not allowed to register itself along with other EUPs under single registration. Participation in linkage auction will not be permitted for the concerned EUP/Bidder. In case of inclusion of such debarred EUP in the registration, all the successful bid(s) obtained under this registration will be liable for termination with consequent penal action. In case, any of the linked EUP/unit under single registration will put under debarment in relation to linkages/FSAs prior to tranche VIII, post participation, the concerned bidder (containing the linked EUP/unit under debarment) will also be debarred to its entirety and successful bid/FSA of the concerned bidder under this scheme will be liable for termination with consequent penal action.
- d. The interested bidders are required to seek registration on the Electronic Platform for bidding purposes against payment of a non-refundable registration fee of Rs. 10,000 (Indian Rupees Ten Thousand) plus applicable taxes.
Bidders already registered for the coal linkage auctions in Mjunction portal may use the same registration for the same Specified End Use Plant and may not register again.
In case any bidder is not registered in Mjunction portal but having MSTC bidder ID & existing linkage, they must register their EUP in Mjunction portal mentioning MSTC registration details. Such re-registration will not attract any further registration fee.
- e. However, in case bidder wants to bring their EUPs of the specific subsector(necessarily under same PAN) located at geographically different location or under different bidder IDs under single registration(as mentioned in point (a) above), the bidder will be required to mention existing registration/ID/linkage & other relevant details while registering their EUPs under single bidder ID. In such case, registration fee will be applicable and registration number will be given afresh by the service provider. The existing registration/related details will be mapped with this new bidder ID. The earlier bidder IDs will be deactivated post completion of this new registration process.
- f. The RFP information of each linked EUP including plant capacity and linked coal block details are to be submitted by the bidder.
- g. Participation will be allowed for cumulative eligible normative quantity of the linked EUPs/units under same registration. However, the supply to individual plant/unit from all coal linkage sources & consumption thereof will not exceed its normative quantity/requirement.
- h. Self-attested copy of PAN & Self-attested copy of GSTIN of the bidder will be required to be submitted to auction service provider for registration process. In case of a proprietorship firm, proprietor's personal PAN card is required. In case of partnership firm, PAN of the firm and that of the authorized partner are to be submitted

B. Offer structure: The offer will be colliery/siding wise mentioning mode of transport. In case of Rail offer, the feeding colliery(ies) of the siding(Primary/Secondary) is to be mentioned in the offer with possible distribution of feeding percentage of coal from linked collieries. The rake may be formed from the coal of the feeding mines with flexibility of $\pm 15\%$ of the proportion from the each feeding mines mentioned in the offer.

C. Supply of coal to linked EUP(s) of a bidder: Linkage coal can be taken to any of the linked plant under common registration (barring any EUP/unit under debarment). However, the MSQ distribution among the plants shall have to declared/submitted 15 days prior to commencement of the concerned month by the bidder to the concerned coal company. In case of non-receipt of distribution matrix, the coal company may use the matrix of last available month for supply of coal. Any change of destination (to other linked unit/EUP) of the Rail program/allotment shall be subject to mutual agreement by Purchaser and Seller and as per extant Railway rules. However, once the Road sale order is issued for quota of any month on account of any EUP/Unit, any change of EUP/Unit will not be allowed for the concerned Road mode Sales Order. The bidder shall undertake not to lift coal from any coal linkages beyond normative coal requirement of individual EUP of the specific subsector.

D. Change of mode:

a. Rail to Road:

- The Road mode supply will be made from the linked mines of Primary source/Secondary source, as the case may be, in the same supply proportion mentioned in the offer notification of the concerned auction, subject to availability
- In case the siding (primary/secondary, as the case may be) is fed by single feeding mine, supply under the mode conversion will be made from the feeding Road source.
- In case siding (primary/secondary, as the case may be) is fed by multiple mines, supply under mode conversion will be made in the same proportion of distribution from the feeding mines of the concerned siding (as mentioned in the offer notification/FSA). Any change on the proportion of such supply from feeding mine will be subject to mutual consent of buyer and seller
- The price payable by the willing FSA holder for supply of coal through the Temporary Road Source(s)(i.e. feeding mine-wise of the siding) would be higher of the following:
 - (a) the As Delivered Price (considering the Modulated/notified Price, as applicable, and Winning premium [%]) for the Primary Rail Source, or
 - (b) the As Delivered Price (considering the Modulated/Notified Price, as applicable, and Winning premium [%]) of the bids for the Temporary Road Source(each of feeding mines of the siding) within the same subsector under the same tranche of NRS Linkage Auction.

Moreover, road source specific charge, if any, shall also be applicable.

Note: In case the feeding mine is not having any price reference in the linkage auction of the same subsector under same tranche, the % premium of original Rail siding will prevail.

- The coal company will be empowered for extending/exercising such facility of change of mode from Rail to Road, on monthly basis, taking into account availability of coal in the concerned mode, rake movement possibility (likely non-materialization of allotted rake), ground level conditions etc. to the willing consumers. Restoration of a quantity to the original mode once transfer of mode has been exercised will not be allowed.
- Change of mode to Road mode will be allowed against allotted rake on the basis of request of consumer. The Road DO validity will however not exceed the 180 days timeline of the Rail mode(from date of allotment) subject to maximum validity of 45 days.

In case of non-materialization of Road DO/sale order(post mode conversion), for the reason attributable to the consumer, penal provision will be applicable.

b. Road to Rail:

- The consumer may request for change of mode to Rail mode from the concerned Road mode quantity to coal company subject to minimum of rake load quantity or in multiple.
If there is possibility of materialization in Rail mode and considering availability/commitment position, the coal company may allow the quantity (in rake load factor multiple) to be converted to Rail mode.
- The Road to Rail conversion will only be allowed in the siding which is fed from a single mine/colliery as per offer notification. Siding with more than one feeding mine will not be allowed for such conversion.
- The price payable by the willing FSA holder for supply of coal through the Temporary Rail siding(i.e. linked Railway siding of the offered Road source) would be higher of the following:
 - (a)the As Delivered Price (considering the Modulated/notified Price, as applicable, and Winning premium [%]) for the Primary Road Source, or
 - (b)the As Delivered Price (considering the Modulated/Notified Price, as applicable, and Winning premium [%]) of the bids for the Temporary Rail siding(linked to Road source) within the same subsector under the same tranche of NRS Linkage Auction.

Moreover, Rail source specific charge, if any, shall also be applicable.

Note: In case the linked Rail siding is not having any price reference in the linkage auction of the same subsector under same tranche, the % premium of original Road source will prevail

- The Rail program will be valid for 180 days from allotment, however, non-materialization of the rake(under conversion) within the validity period will lead to penal action for the unmaterialized quantity as per FSA provision

E. Cut off date: Bidders having expiring FSAs till 30.09.2025 are allowed to participate in tranche VIII NRS Linkage auction in the specific subsector for the concerned quantity beside residual eligible quantity.

F. Processing fee: Rs. 30/ton(incl taxes)

G. Bid security: Rs. 150/ton(incl taxes)

The above details are provided for information of the stakeholders for tranche VIII NRS Linkage auction. Detailed terms & condition and clauses regarding tranche VIII NRS Linkage auction will be mentioned in the Scheme document of specific subsector and FSA document which will be final and binding in nature.

- Communication from Statutory authorities like CBI, Police, Court of law etc. containing allegations/finding/ establishing charge(s)of misutilization of coal against any non-power unit and/ or its director/management.
- Finding of the instance of misutilization of coal internally by the coal company.

B. Guiding principle regarding banning/blacklisting of consumers for misutilization/misdirection of coal:

- Prior to suspension or banning for supply/participation, as it may, a notice calling for explanation will be issued by the supplying coal company, pursuant to approval of competent authority, to the alleged customer.
- The period of suspension/banning shall be for a period of 5 years. In case the reason of such suspension is mitigated earlier then the suspension will stand accordingly withdrawn.
- Wherever the reason of suspension is not completely mitigated (because of reasons like pendency of trial or no clearance given by enforcement authority etc.), the period of suspension to be extended till the time of acquittal or a direction/clearance is given by enforcement authority/ Court or maximum period of banning, as imposed, whichever is earlier. However, participation in linkage auction shall not be restricted as long as charge sheet is not filed against the consumer.
- Wherever the allegations stand proved, all running coal supply agreements will be terminated forthwith with corresponding forfeiture of EMD/Security Deposit, as a penalty towards the breach. Moreover, further participation in Linkage auction by the plant shall also be banned till completion of tenure of suspension/banning.

C. Detailed Guideline regarding period of suspension/banning covering the aspects of supply of coal under FSA and participation in linkage auction:

1. Complain regarding misutilization of coal received from statutory authorities/ CBI/ Investigating agencies:

i. Supply of coal under Fuel Supply Agreement:

- a. Upon receipt of any adverse report/ order, coal supply and further transaction under Fuel Supply Agreement will be stopped for concerned non-power unit immediately.

b. If charge sheet is not filed before relevant adjudicating forum within 6 months of such suspension, the supply/transaction will be resumed with the condition (rider) that suspension may be re-imposed on filing of chargesheet at any point of time, under intimation to the concerned authority. In case charge sheet is issued subsequently, supply/transaction will again be suspended.

c. If the charge sheet is filed within six months of such suspension, the suspension of supply and transaction will continue.

d. In case charge sheet is filed, suspension will be re-imposed and supply of coal will only be restored as per terms of FSA only on acquittal/clearance or an order to that effect by the investigating agency or Court.

e. In case a unit or its director is found guilty/convicted, suspension will continue for a period of 5 years, effective from the date of commencement of last suspension or the completion of penalty, whichever is later.

f. Since any conviction amounts to material breach of the agreement, the EMD/Security deposit, as it may, in such cases shall stand forfeited.

ii. Participation under NRS Linkage auction:

a. On receipt of communication from statutory authority, the consumer put under suspension will be eligible to participate in the NRS Linkage auction till charge sheet is filed. However, in case the charge sheet is filed, the unit will not be eligible to participate in any auction and/ or to sign the FSA till his acquittal/clearance.

b. In case charge sheet is not issued within 6 months of completion of auction of the relevant subsector (where the unit has participated) FSA shall be signed and supply shall be commenced. However, such supply shall be guided by the procedure mentioned at 1(i) above.

c. In case charge sheet is issued within 6 months of completion of auction of the relevant subsector (where the unit has participated), the bid shall not be converted to FSA and relevant bid security shall be forfeited.

d. If found guilty/convicted, banning for participation will continue for a period of 5 years effective from date of commencement of last suspension/ date of conviction, whichever is earlier.

2. Misutilization of coal as per findings of coal company:

i. Supply of coal under Fuel Supply Agreement:

a. On finding the evidence/proof of diversion of coal or discrepancy in the coal stock (5% or more) against coal procured under any of present FSA, will be sufficient reason to put concerned NRS linkage holding unit under suspension.

b. On scrutiny within 3 months from the date of primary suspension, if misutilization is not proved, the coal supply shall be resumed.

c. In case misutilization of coal under any present or past FSA is proved at any point of time, supplies to the unit will be suspended for 5 years. In such case, all running FSA/LOI will be terminated as per provision of Scheme/FSA/guideline by treating it as gross material breach of the intent for which agreement(s) was/ were entered into with consequent forfeiture of EMD/ SD, as it be.

ii. Participation under NRS Linkage auction:

a. On finding the evidence/proof of diversion of coal or discrepancy in the coal stock (5% or more) against coal procured under any of present FSA, participation in linkage auction of the unit shall not be restricted. However, signing of FSA shall be put on hold for the time being.

b. In case misutilization is not proved within 3 months from the date of primary finding by Coal Company, FSA shall be signed. Supply shall be guided by the above mentioned methodology as at 1(i) above.

c. In case misutilization of coal under any present or past FSA is proved at any point of time, participation under NRS Linkage auction shall be suspended for maximum period of 5 years from the date of communication of such order to this effect.

D. Show Cause Notice: All the above cases where coal supplies are to be suspended & signing of FSA withheld or FSA is contemplated to be terminated, a prior Show-Cause notice shall be issued to the concerned party.

E. Change of Plant ownership: In the event of transfer of end use plant/takeover of a company/change of management/change of name etc. (including but not limited to NCLT and other Governmental proceedings) during the period of debarment, the new owner shall remain debarred for the remaining period of suspension of 5 years.

F. Undertaking by Unit: All the bidders/ FSA holders shall submit an undertaking in the form of an affidavit sworn before appropriate authority about factual status of investigations, if any and its current status against them by investigating agency or Court of law, regularly once a year.

G. Treatment of cases against which misutilization of coal was reported earlier and action already taken by coal companies-

The above provisions will also apply to all the units uniformly, including those suspended earlier, and based on certain reference/ findings of Coal Company / statutory authority. In case the stipulated period of suspension/ banning, as it may, has already exceeded five years, the status of such units shall stand restored automatically, in line with aforesaid recommendations. Coal company shall make necessary intimation/communication to all concerned including Linkage Auction service provider regarding invoking and revoking banning/suspension for supply/participation on any unit/consumer, as deemed required.

This above guideline shall be applicable with immediate effect.

**Sub : Addendum of clauses regarding conditions for supply of coal
under NRS Linkage Auction FSAs**

Ref : Fuel Supply Agreement (FSAs) with the successful bidders of Linkage Auction under NRS Linkage Auction Policy issued by MOC on 15.02.2016.

In accordance with the letter No. CIL/M&S/Linkage Auction/70, dated 09.02.2021, issued by HOD/Commercial (M&S), CIL (copy placed at Annex-I), the following condition is being introduced in reference to the FSAs (executed and to be executed) under NRS Linkage Auction Policy with respect to supply of coal and termination of Agreement, as an additional clause no. 21.19 under 'Miscellaneous'.

21.19 In case any consumer, drawing coal under NRS Linkage Auction FSA, is charge sheeted by any Investigating Agency of Government or Law Enforcing Authority of Government or any other Governmental Authority for wrongful utilization/misutilization/diversion of coal, supply of coal will be kept in abeyance without financial obligation of either Seller or Purchaser, till it is cleared or till the 'Term' of the FSA whichever is earlier. In case the consumer is convicted, Fuel Supply Agreement will stand terminated with forfeiture of Security Deposit. It shall be the responsibility of the consumer to report such development to the seller.

This clause shall have bearing in the relevant clauses of the FSA.

All the Fuel Supply Agreements under NRS Linkage Auction Policy stand amended to this effect in pursuance of the clause 'Amendment' under FSA. In case of change in clause number in FSA model, the above clause is to be considered as last clause under 'Miscellaneous'.

All the Buyers/Purchasers are hereby informed to take note of the above introduced provision.

The 232nd CIL FDs meeting held on 27.06.2020, after detailed deliberation accorded its approval for extending to Non power sector consumers to revalidate shortfall quantity and lift coal to the extent to ACQ under FSA, the relevant portion of which is as follows:


Quote:

1. Purchasers who could not off take the MSQ quantity (Scheduled quantity or SQ as per FSA) during Apr-June 2020 under NRS Linkage Auction FSA for any reason whosoever may be allowed to book the unlifted / unbooked quantity in the subsequent months of current FY subject to availability of the coal at the coal company.
2. The willing consumers has to submit an undertaking stating that the coal taken under this relaxation shall be utilized against requirement of their EUP and they shall not procure the coal to the extent of such shortfall quantity through import during current FY.
3. The above dispensation of carryover of unlifted / unbooked quantity in a particular month shall be allowed for the entire FY subject to availability of coal at the coal company and within the ceiling of ACQ.
4. The same dispensation may also be extended for the willing non power FSA consumers other than NRS Linkage Auction also to the extent of their ACQ irrespective of Import component under FSA. However, the same shall be allowed subject to fulfillment of all commercial obligation including performance security as per FSA provision.
5. The above dispensation shall be optional in nature.
