## Online submission – Digital Life Certificate / Jeevan Pramaan

The CPRMS beneficiaries can visit either CIL(HQ), Kolkata, or a nearby Citizen Service Centre, Bank Branch or any Government office whose details are provided on <https://jeevanpramaan.gov.in/locatecentre> and biometrically authenticate his / her life certificate in real time. CIL will receive the Life Certificate automatically after biometric authentication.

### NOTE:

- For couple membership i.e. both retired executive and his/her spouse is alive – 02(two) separate Digital Life Certificate has to be generated.

## FOR POST-RETIREMENT MEDICAL (CPRMSE)

CPRMS-E beneficiary needs to generate **Two (02)** Jeevan Pramaan Certificates / Digital Life Certificates using Biometric Authentication or Face Authentication based on UIDAI Aadhaar Software

- For self-i.e. the retired executive
- For the spouse of the retired executive
- ✦ Disbursing Agency: **SELECT CIL**
- ✦ Sanctioning Authority: **SELECT CIL**
- ✦ **PPO number: ENTER MEDICAL CARD NO;**
- ✦ **EX: CIL/E/0040 OR ECL/E/0040; CIL/S/0040 OR ECL/S/0040**

*A retired executive of CIL shall submit in total 03 (three) Jeevan Pramaan Certificate.*

- 1. One (01) Certificate for Pension*
- 2. Two (02) Certificates for Post-Retirement Medical-*

- a. One for Self (i.e. retired executive)*
- b. Another for his/her Spouse*
