

The appointment is provisional and subject to verification of certificates/documents from concerned Authorities as per norms of the company and in case at any subsequent stage of appointment, if it is detected that the certificates are not genuine, their services can be terminated based on the certification report of the concerned authorities.


The above-mentioned Sr. Medical Officers in E3 grade will be on probation for a period of one year which may be extended at the sole discretion of the Management depending on the performance of the executive. On successful completion of the probationary period of service he/she will be confirmed as regular employee.
