OFFICE ORDER

In pursuance to the office order no. CIL/C5A(V)/DPC/E7-E8/24/Fin./B-730 dated 14-08-2025 issued by the General Manager (HR)/EE, CIL HQ, Shri Rajib Lahiri, EIS No. 90045659, Chief Manager (Fin) presently posted at Marketing & Sales Department, ECL HQ, has been promoted to the post of General Manager (FIN), in E-8 Grade in the scale of pay ₹1,20,000-2,80,000/- with posting at BCCL till further orders.

Subsequently, vide office order no. CIL/C-5A(ii)/B-825 dated 15-09-2025 issued by the General Manager (HR/EE), CIL HQ, Shri Rajib Lahiri, EIS No. 90045659 promoted to the post of General Manager (Fin) at BCCL vide aforesaid office order no. B-730 dated 14-08-2025 has further been posted as Director (Finance) of Jharia Rehabilitation & Development Authority (JRDA) till further orders.

Accordingly, Shri Rajib Lahiri Chief Manager (Finance) is hereby released from ECL with immediate effect with an advice to report to the CMD, BCCL in his promoted post in E8 grade & for his further posting at Jharia Rehabilitation & Development Authority (JRDA), keeping his roll in BCCL during his tenure at JRDA in accordance with the aforesaid office order no. B-825 dated 15-09-2025.

The above executive has to join the promoted post at BCCL within 60 (sixty) days, from the date of issue of the order dated 14.08.2025 of CIL, failing which the Promotion Order may be liable to be cancelled abinitio.

On being formally released from his present department of posting (*positively by 10th October 2025*), Shri Lahiri will report to the CMD, BCCL, accordingly.

On promotion, the above Executive will be on probation for a period of one year at the first instance or date of superannuation, whichever is earlier.

The promotion will be effective on and from the date, the above Executive assumes charge of the higher post, at the place of posting on promotion as mentioned above.

The order shall abide by the ultimate adjudication in the Writ Petition nos. 19607(W) of 2017 with no. 9754(W) of 2017 (Bani Singh Rana & Ors. With Pijush Kumar Singha & Ors. Vs. CIL & Ors.) before the Hon'ble High Court of Calcutta.
