2. ENGAGEMENT PROCEDURE FOR PGPT AND PDPT:

- i) Candidate must report at Office of the General Manager, HRD, Dishergarh, Paschim Burdwan, WB, 713333, with **call letter from BOPT (Board of Practical Training)** and **all necessary documents in original** (mentioned below) and duly filled in application format and undertaking (which is available on ECL website) on the stipulated date as mentioned in call Letter.
- ii) Application form shall be dully filled in and complete in all respect.
- iii) After scrutine and verification of documents, successful candidates will be issued training engagement letter. Place of Apprenticeship Training shall be decided by the General Manager (HRD), ECL. Training engagement letter will indicate place of posting, date of appointment and date fixed for contract creation at HRD Department, ECL. During verification of documents, if any discrepancy is found between the documents submitted on NATS portal and the original, then the candidature will be summarily rejected without any further query and company also may take legal action against the candidate for forgery etc.
- iv) Candidate must join at their respective place of posting on the date as mentioned in the engagement letter.
- v) After joining at their respective place of posting, a joining letter will be issued to the candidate from their place of posting.
- vi) Candidate must report to HRD office again with the copy of joining letter for creation of contract on portal on the date as mentioned in their engagement letter.
- vii) Candidates will be required to provide an undertaking that they will not claim any employment in ECL after completion of the apprenticeship training.

4. PAYMENTS:

For PGPT- RS 4500/- per month by ECL and Rs 4,500 /- per month by Gol as DBT through BoPT.

For PDPT- RS 4000/- per month by ECL and Rs 4,000 /- per month by Gol as DBT through BoPT.

Aadhaar must be enabled for DBT (Direct Beneficiary Transfer) to receive Gol share as applicable.

5. SAFETY CLAUSE

Employers liability in case of injury to Apprentices will be limited as per Apprentice Act,1961, however Employer shall not be responsible for any injury ,loss or accident suffered by the apprentice arising out of his negligence or willful disregard of safety instruction or failure to comply established safety protocols or unauthorized or unsafe operation of machinery without supervision.



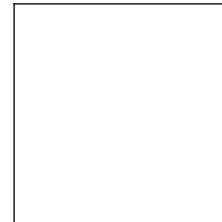
